The Bureau of Quality Management has completed its review of the above-referenced staff's credentials to determine whether they meet the state and federal job and educational requirements to perform work as a Qualified Intellectual Disabilities Professional (QIDP). Based on the information provided by your organization, the Bureau has determined that this candidate meets the state and federal standards and is approved to be added to the state QIDP database.

Please make a copy of this notification available to the QIDP candidate.

In addition, the following comments are provided for your information:

- Individuals who initially started work as QIDPs on or after October 1, 1999 are required to successfully complete an approved QIDP Basic Orientation training program within six (6) months of employment as a QIDP. This training must be documented and kept in the individual's personnel/training file.
- All QIDPs must have 12 hours of continuing education (CEs) each state fiscal year beginning the first state fiscal year after completing the 40-hour QIDP Orientation training. Six (6) of the 12 annual CE hours must be obtained outside the employing agency. This training must be documented in the individual's personnel file.
- QIDPs who have a gap in service of less than two years will not need to repeat the QIDP training as long as they meet the annual continuing education requirement.
