3.1 Level of qualification: 1st Cycle

8 SEMESTERS, 240 ECTS.
A full academic year is equivalent to 60 ECTS units and each semester to 30 ECTS (European Credit Transfer System) (1 ECTS=25 -30 student work load hours). Compliance with the ECTS (European Credit Transfer and Accumulation System) regulations started in 2007, when the Greek Legislation was harmonized with the relevant European one (Ministerial Decision no Φ5/89656/β3, art. 1-3, Hellenic Government Gazette no 466/2007/B). A full academic year is equivalent to 60 ECTS units and each semester.
